

Adams County Nebraska, Notice of 2026 Primary Election

Notice is hereby given that on Tuesday, the 12th of May, 2026 at designated polling locations in the precincts of Adams County, Nebraska an election will be held. The polls will be open at 8:00 a.m. and will close at 8:00 p.m. CST. Said election will be for nominating candidates to various offices. The Secretary of State will publish a true copy of the title and text of any amendment or referendums once each week for three consecutive weeks preceding the election.

Pursuant to §32-811, some partisan and nonpartisan races will not appear on the Primary Election. If the names of candidates properly filed for nomination at the Primary Election do not exceed twice the number of vacancies; Partisan Office races when only one filing is received and no write-in affidavit is received by March 1; any such candidates shall be declared nominated and their names shall not appear on the Primary Election ballots. The official Abstract of Votes for the Primary Election shall show the names of such candidates as NOMINATED WITHOUT OPPOSITION and their names will automatically advance to the General Election ballot.
