

**Adams County Highway Dept
Continuous Local Oversize/Overweight Permit**

Attach copies of State Permits to determine Truck and Trailer and Load descriptions

A. Rules:

1. A slow-moving building/large object is defined as a building or large object in excess of legal dimensions for width, length, height, or any combination thereof that must be moved at a slow speed, typically 30 mph or less.
2. The application for a permit to move a slow-moving building/large object on a county road shall be made to the Highway Superintendent's Office a minimum of 5 days in advance of the date of the move to provide for review and approval OR a **"Term Permit" may be requested.** (Term Permit Cost is \$50 per unit; Truck @ \$50 & Trailer @ \$50 for a total of \$100 per registered unit)
3. An additional local permit may be required for moves on City or Village roads. The applicant is responsible for contacting those local authorities.
4. The applicant must provide a certificate of insurance (ACCORD FORM) for public liability and property damage in an amount not less than \$1,000,000 to Adams County prior to the move. The certificate must state that 10 days' notice will be given to the county before cancellation.
5. Adams County will require the mover or its' insurance company to reimburse the county for any damages to the road system or structures and incorrectly placed signs thereon by reason of the move and the mover shall pay the cost of expenses for inspection of the move by Adams County.

Travel

Route Option 1- Adams County Truck Route on 42nd St from HWY 34/281 east to Showboat Blvd, then south to Hwy 6.
Maximum allowable weight of 204,000 lbs. (102 Tons) of weight AND no more than 20,000 lbs. per axle weight

Route Option 2- City/ County Truck Route on 26th St. from HWY 34/281 and Osborne Drive going East, going east on 26th St to Showboat Blvd, then south to Hwy 6. Maximum of 204,000 lbs. (102 Tons) of weight AND no more than 20,000 lbs. per axle weight

Route Option 3- City/ County Truck Route on Showboat Blvd Starting at Hwy 6 then South to "J" Street then West to Hwy 6.
Maximum of 204,000 lbs. (102 Tons) of weight AND no more than 20,000 lbs. per axle weight

NOTE: All described Routes and Conditions Stated herein are also recognized and approved for use by the City of Hastings per the City Engineer's review with County Highway Superintendent's signature

Provisions

Permit travel is prohibited if any of the following adverse or inclement weather conditions exist:

- * Winds cause a hazard to movement.
- * Visibility is less than one-half mile.
- * Rain, sleet or snow.
- * Highway surfaces are slippery due to ice, snow, packed snow, slush or frost.
- * Debris from an accident, natural disaster, or emergency on the highway.

Wet pavement, light drizzle, or wind less than 25 miles per hour are not considered inclement weather for purposes of permit movement. If adverse weather or road conditions are encountered during operation, the permitted vehicle must proceed to the next available safe place off the roadway and park until conditions improve. Nebraska State patrol Officers or local law enforcement officers or Nebraska Department of Transportation personnel may further restrict or prohibit operation of permitted vehicles during periods, when, in their judgment, weather or other hazardous conditions make continued operation unsafe.

Permittee must bypass any and all clearances that are less than the above listed dimensions. The permittee shall assume the risk of loss to the vehicle or its load and shall be liable for any damages that result to overhead obstructions from operation of a vehicle exceeding 12 foot 6 inches in height.

60-6,288(1) Any person moving a building or an object that, in combination with the transporting vehicle, is over fifteen feet six inches high or wider than the roadway on a county or township road shall notify the local authority and the electric utility responsible for the infrastructure, including poles, wires, substations, and underground residential distribution cable boxes adjacent to or crossing the roadway along the route over which such building or object is being transported. Notification shall be made at least ten days prior to the move. Notification shall specifically describe the transporting vehicle, the width, length, height, and weight of the building or object to be moved, the route to be used, and the date and hours during which the building or object will be transported. Complying with the notification requirement of this section does not exempt the person from complying with any other federal, state, or local authority permit or notification requirements.

(2) Proof of the notification required under subsection (1) of this section must be carried by any person moving a building or an object as described in this section.

(3) Any person who fails to comply with the notification requirements of this section shall be guilty of a Class II misdemeanor.

60-6,299 (1) Hauler is not authorized to manipulate overhead high voltage lines or conductors or other such components, including electric utility poles, the applicant shall be guilty of a Class II misdemeanor for any violation of this section or of the notification requirements of section 60-6,288.01.

- Any dummy axle must carry at least the lesser of 8,000 pounds or 8% of the total gross weight.
- The granting of the permit does not exempt the permittee from compliance with any ordinances, rules and regulations or laws of the State of Nebraska or Federal Government. Permit is subject to revocation upon noncompliance.
- The granting of the permit shall not be construed as waiving any weight limitation that has been, or may be, established on any other highway or any bridge thereon.
- The permit is not transferable to any other vehicle.
- Permittee agrees to hold harmless the Adams County, its agents/employees, contractors and subcontractors from all suits, damages, or proceedings of any kind and to indemnify the Adams County, its agents/employees, contractors and subcontractors for any claims it may be required to pay arising from the permitted move.
- Maximum allowable weight for interior bridge and/or axle groups shall not exceed 25% of the legal weight as determined by NE State Statute 60-6,294.
