DURING THE TIME OF THIS MOTOR VEHICLE CRASH, THERE WERE WHITE OUT CONDITIONS AND A SNOW SQUALL WARNING FOR THIS LOCATION. VISIBILITY WAS LOW TO NONE. VEHICLE 1 AND VEHICLE 2 WERE BOTH EAST BOUND ON HIGHWAY 6. VEHICLE 2 WAS IN FRONT OF VEHICLE 1. VEHICLE 2 CAME TO AN ABRUPT SLOW/STOP. VEHICLE 1 ATTEMPTED TO SWERVE TO AVOID A COLLISION. HOWEVER, VEHICLE 1'S RIGHT FRONT COLLIDED WITH VEHICLE 2'S LEFT REAR. VEHICLE 2 ADVISED THAT THEY HAD TO COME TO AN ABRUPT SLOW/STOP TO PREVENT A COLLISION WITH THE VEHICLE IN FRONT OF THEM THAT WAS SLOWED/STOPPED IN THE ROADWAY. THIS VEHICLE IS UNKNOWN.

UNIT 1 WAS TRAVELING EASTBOUND ON HIGHWAY 6 AND UNIT 2 WAS TRAVELING WESTBOUND. UNIT 2 TURNED SOUTH ONTO REPRISAL AVENUE FROM HIGHWAY 6, TURNING IN FRONT OF UNIT 1. UNIT 1 COLLIDED WITH THE PASSENGER SIDE OF UNIT 2. EXPLANATION OF VEHICLE 2 "DRIVER ACTION AT TIME OF CRASH" "OTHER CONTRIBUTING ACTION" VEHICLE FAILED TO YIELD TO VEHICLE 1, DUE TO THE LACK OF VISIBILITY FROM THE WEATHER CONDITIONS.
