THE MATTRESS BECAME LODGED UNDER THE VEHICLE AND CAUGHT ON FIRE. DRIVER WAS ABLE TO MOVE THE VEHICLE OFF THE ROAD BUT WAS UNABLE TO PUT OUT THE FIRE. THE VEHICLE BECAME ENGULFED IN FLAMES.
