AT APPROXIMATELY 1548 HOURS, A COLLISION BETWEEN TWO MOTOR VEHICLES OCCURRED AT THE INTERSECTION OF ADAMS CENTRAL AVENUE AND DLD ROAD. UNIT 1, A WHITE RAM PICKUP, WAS AT THE STOP SIGN ON DLD RD, EAST BOUND. UNIT 2, A BLACK CHEVY PICKUP, WAS NORTHBOUND ON ADAMS CENTRAL AVENUE. UNIT 1 ACCELERATED EAST FROM THE STOP SIGN ON DLD RD, WITH DISREGARD OF UNIT 2, WHICH WAS NORTHBOUND, TRAVELING AT APPROXIMATELY 50 TO 55 MPH. THE FRONT RIGHT SIDE OF UNIT 1 COLLIDED WITH THE FRONT LEFT SIDE OF UNIT 2, CAUSING UNIT 2 TO RUN OFF THE ROADWAY TO THE RIGHT, INTO A FIELD ON THE NORTHEAST SIDE OF THE INTERSECTION, DAMAGING A STREET SIGN IN IT'S PATH. UNIT 1 SPUN APPROXIMATELY 180 DEGREES LANDING ON ADAMS CENTRAL AVE, FACING WESTBOUND. A CITATION WAS ISSUED TO THE DRIVER OF UNIT 1 FOR VIOLATING THE PREFERENTIAL RIGHT-OF-WAY OF A STOP SIGN, NE STATUTE 60-6,148.
