Week Summary:

58 calls for service, 101 Civil Court documents served, 11 warrants served, 38 traffic contacts made, 25 subjects booked into the Adams County Jail.

April 13, 2026

SEMI-TRACTOR AND TRAILER WAS SOUTHBOUND ON CONESTOGA AVE. WHEN THE DRIVER FAILED TO YIELD TO AN EASTBOUND TRAIN. THE TRAILER WAS SPLIT IN TWO PIECES AND CAME TO REST ON EITHER SIDE OF THE TRACKS. DRIVER STATED TO ANOTHER OFFICER, HE DID NOT LOOK WESTBOUND PRIOR TO CROSSING THE TRACKS. TRAIN CREW ARE LISTED IN THE WITNESS PORTION OF THE REPORT. THE TRAIN WAS COMPRISED OF ONE HUNDRED EMPTY TRAIN CARS.
