April 20, 2026

DRIVER OF VEHICLE STATED WHILE SOUTHBOUND ON ADAMS CENTRAL AVE. SHE LOOKED DOWN AT HER PHONE. DURING THIS TIME THE VEHICLE LEFT THE ROADWAY TO THE RIGHT. THE VEHICLE RE-ENTERED THE ROADWAY, OVER CORRECTED AND ENTERED THE WEST DITCH. THE VEHICLE OVERTURNED ONTO ITS ROOF AND SLID INTO A POWER POLE. HASTINGS UTILITIES OBSERVED THE POLE FOR DAMAGES AND FOUND NONE.

The Adams County Sheriff's Department investigated an accident near Hwy 281 and 70th St.

THE DRIVER OF THE VEHICLE ADVISED THAT HE WAS TRAVELING NORTHBOUND ON HIGHWAY 281, WITH HIS CRUISE CONTROL SET AT APPROXIMATELY 72 MPH. THE DRIVER STATED THAT THERE WAS LIGHT RAIN AT THE TIME OF THE CRASH, AS THEY RECALL THAT THEIR WINDSHIELD WIPERS WERE SET ON LOW. THE DRIVER SAW AN AREA OF STANDING WATER ON THE ROADWAY SO THEY TAPPED THEIR BRAKES TO TURN THE CRUISE CONTROL OFF. WHEN THE VEHICLE HIT THE WATER IN THE ROADWAY, THE DRIVER EXPLAINED THAT THE VEHICLE HYDRO PLANED OFF THE ROAD AND TO THE RIGHT SIDE OF HIGHWAY 281, THRUSTING THE VEHICLE INTO THE EAST DITCH AND UP AN EMBANKMENT. THE WEATHER ON THIS DAY WAS INTERMITTENT DOWN POURING RAIN. WHEN THIS OFFICER ARRIVED ON SCENE, THERE WAS STANDING WATER IN THE DITCH AND IT WAS RAINING HEAVILY.
